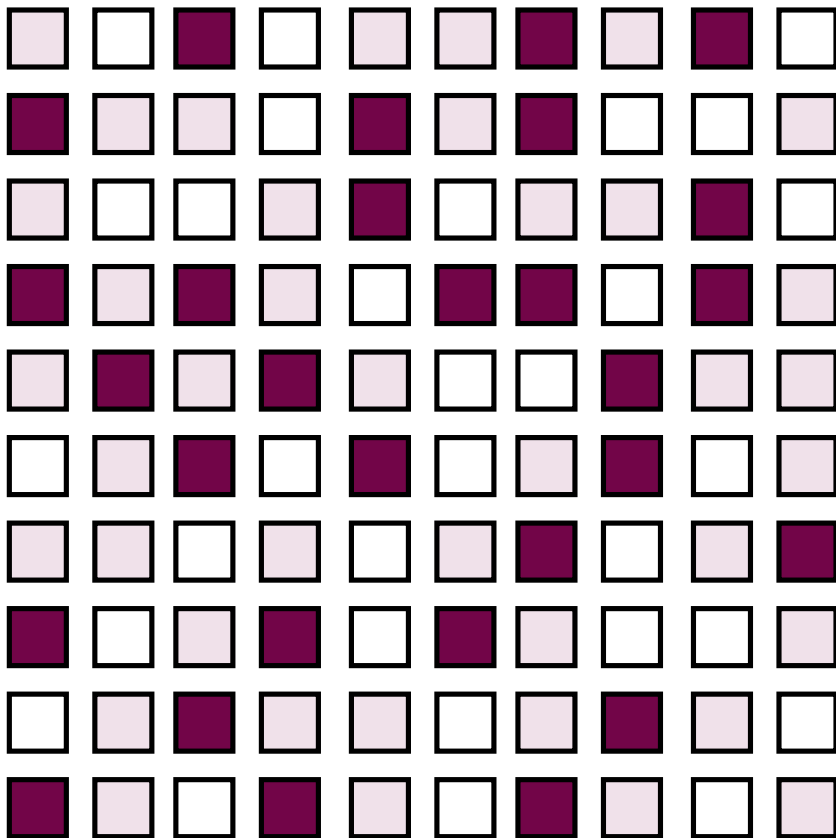

2006 Leadership Conference

The first ever Phi Sigma Rho Leadership Conference was held in July in Dayton, Ohio. The Foundation's \$1000 grant to the conference helped support the LEAP workshops on valuable topics including Work/Life Balance, Communication & Leadership Styles and Career Management. The Leadership Conference, with an attendance of 70 members, represented almost 10% of Phi Sigma Rho active sisters and almost 2% of our alumnae membership. Feedback provided during and after the conference demonstrated a sustained impact on the attendees.

Why is there a Foundation? Why aren't National dues enough?

By having a Foundation, Phi Sigma Rho is able to accept tax deductible contributions that the Sorority does not have the capability to do. In order to help our sisters develop and support their achievements, the Foundation was created by Phi Rhos for Phi Rhos.

How is the Foundation different from the Sorority?

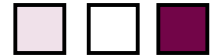
They are separate legal entities. The Foundation is a nonprofit, charitable 501(c)3 organization and the Sorority is a nonprofit 501(c)7 membership organization.

Where does my money go and who does it help?

Donations are used to cover operating expenses and towards Phi Sigma Rho programs. In addition, the Foundation is able to assist active members through scholarships as well as Sorority funded education and leadership initiatives.

Right now, I'm only able to make a gift of \$20, and tax deductibility certainly isn't my motivation. I'd like to do more and plan to do that some day, but I can't believe my twenty bucks now will make much of a difference.

You would be surprised what \$20 can do! Not necessarily by itself but your gift is "pooled" with others of like amount, smaller or larger. Suddenly, the impact of those gifts combine to do wonderful things for Phi Sigma Rho. Simply put, there are no small gifts!

GoodSearch

Goodsearch is a search engine which donates 50 percent of its revenue to the charities and schools designated by its users. Powered by Yahoo!, the money originates from the advertisers and neither the charities nor the users pay anything.

The Phi Sigma Rho Foundation is now a part of GoodSearch. Simply navigate to <http://www.goodsearch.com>, enter Phi Sigma Rho into the text box labeled "Who do you search for?" and press the Verify button. Now, every time you search using GoodSearch you generate funds which are then donated to the Foundation. They even make it easy by providing toolbars for Internet Explorer and Firefox.

So go ahead and search but make it GoodSearch and help the Foundation. There's no reason not to!

Giving Levels

Giving levels are distinguished by total gifts or gifts in-kind annually and throughout a lifetime. A level is rewarded if the minimum amount of that level is given or donated in kind. If a donor level is met for a period of five years, a reward of the Circle of Contributions is given. Also, the Foundation recognizes collegiate and recent graduate donations with its Collegiate Programs. Finally, a Living Legacy is rewarded to those who bequeath donations to the Foundation in their will.
